Queen's Park Update: Government Moves on Legislative Priorities, Including Hydro One Executive Compensation

On the heels of Hydro One's board resignation and the retirement of its CEO, Minister of Energy, Northern Development and Mines Greg Rickford introduced an omnibus bill on July 16 entitled Bill 2, *the Urgent Priorities Act*. The omnibus bill enacts the *Hydro One Accountability Act*, which would require the incoming board at Hydro One to establish a new compensation framework for itself and for the utility's CEO. The act would also give cabinet veto power over this compensation framework and any future changes to it.

In addition, the act would require Hydro One to publish on its website a record of the total annual compensation paid to executives. An amendment to Section 78 of the *Ontario Energy Board Act* would further require the

Ontario Energy Board to exclude any compensation paid to the board, CEO and its executives from ratepayers' bills.

The deal reached by the government with Hydro One's board before their resignation also included a non-disparagement clause that bans the government from saying anything that "defames, criticizes, ridicules, disparages or is derogatory ... to any of the directors, officers, employees, agents and/or representatives of Hydro One." The legal immunity afforded to MPPs by parliamentary privilege means these terms will not apply during debates in the House.

In the legislature, Speaker Ted Arnott ruled on how he would manage question period participation for the seven Liberal members and one Green Party member. Arnott said he will allow one question from an independent member per question period which means one question per Liberal or green MPP every two weeks.

Hydro One and electricity price criticisms remained a key theme in the inaugural Question Period of this new session of the legislature. As Leader of the Official Opposition, the NDP's Andrea Horwath used the first question to press Premier Doug Ford on transparency related to the Hydro One decision.

Minister of Energy, Northern Development and Mines Cancels 758 Renewable Energy Contracts

Savings for customers estimated at \$790 Million

Last Friday, the Hon. Greg Rickford, Minister of Energy, Northern Development and Mines, announced that the Government of Ontario is [cancelling 758 renewable energy contracts](#), as part of its plan to reduce electricity bills. The government estimates this action will result in savings to

OEB Approves OPG Charges to Fair Hydro Trust

On July 5, the OEB issued its Decision and Order authorizing OPG to:

- charge the Fair Hydro Trust \$5.676M in fees for the period June 1 – December 31, 2017; and
- use OEB authorized interest rates to calculate the fee to be charged to the Fair Hydro Trust for the period January 1, 2018 to March 31, 2019.

The application was decided by OEB members Duff, Frank and Janigan who, in large part, without a hearing, approved OPG's applications.

OPG's two applications dealt with the charges to be made by OPG to the Fair Hydro Plan Trust:

- EB-2017-0375, dated December 15, 2017, sought OEB authorization of the estimated \$500,000 – \$5,000,000 base fee and the incentive fee to be charged by OPG for the period January 1, 2018 – March 31, 2019; and
- EB-2018-0102, dated February 28, 2018, sought approval of a \$5,676,000 fee to cover the costs incurred between June 1, 2107 to December 31, 2017 related to establishing financing, the Financial Service Manager's costs (e.g., for underwriting) and for OPG employees working exclusively on the Fair Hydro Trust.

The Decision notes that O Reg 206/17 provides clear rules on the amounts and eligibility requirements and that it effectively limits the OEB's decision-making powers. The OEB provided four reasons for proceeding without a hearing and granted OPG's request to treat its banking information confidentially.

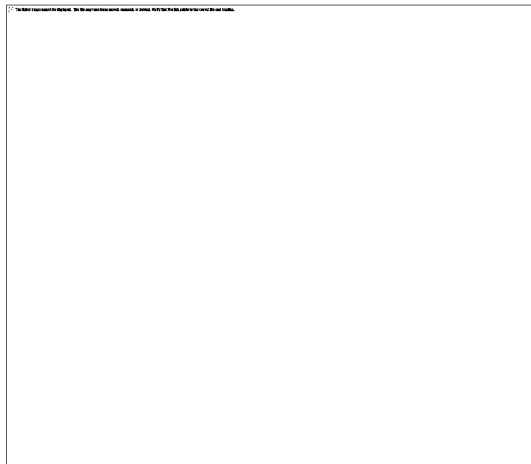

This Friday, July 20 is your last chance to submit nominations to the EDA

The EDA is seeking nominations from our LDC membership base to serve on the EDA's Market Renewal Program (MRP) Committee. The MRP Committee's mandate is to engage in and assess distribution-related MRP issues, as they emerge and evolve. The intent is for the MRP Committee to meet monthly via email, in person and/or conference call.

The IESO's Market Renewal Program

The IESO's MRP started in 2016 and is expected to continue until 2020 or 2021. The MRP is driven by a need to overcome acknowledged market inefficiencies that are putting artificial upward pressure on commodity prices, along with a need to refresh the IESO's software. The IESO has organized four MRP work streams that will ultimately result in changes to the IESO's energy market and establishment of an IESO-administered capacity market.

The EDA's MRP Committee

The EDA's MRP Committee will consist of at least **six LDC members**. Members are required to:

- possess subject matter expertise directly relevant to IESO market design and how it impacts LDC activities, operations, deliverables and risks;
- be strategic thinkers who can contribute to the EDA's advocacy with the IESO and others; and
- be able to engage the decision maker(s) at your LDC on MRP issues.

EDA staff will liaise with the MRP Committee at least monthly, commencing August 2018, and will engage the Committee on an as-needed basis to address specific issues. Committee members are expected to attend and participate in all meetings.
