After “How am I charged for Global Adjustment?” section:

How does the Fair Hydro Act impact Global Adjustment?

For eligible consumers who pay Regulated Price Plan (RPP) prices set by the Ontario Energy Board, the electricity bill mitigation initiatives will be implemented through RPP prices. For consumers that are eligible for electricity bill relief under the OFHP Act but are not paying RPP prices, electricity bill mitigation will be implemented through a reduction in the Global Adjustment charges that they would otherwise pay (the GA Modifier). Effective July 1, 2017, under the Fair Hydro Act, 2017, a portion of the GA will be refinanced to provide rate relief to eligible (RPP and other specified customers) by

spreading the cost of electricity investments over time. For more information, see the Fair Hydro Act, 2017.
