Beyond what is in the deck, there other questions below that we expect may arise. We weren't sure if we should address them in the version that goes to the board, or deal with them when we have more details around the content of the report.

1. Did the IESO ask its auditors to change their previously-issued opinions in order to support regulated accounting?
2. Did the IESO receive direction from the Provincial Controller's Office to change its accounting policy to reflect regulatory accounting, in order to facilitate the Fair Hydro Plan?
3. Did the government ever state their desire to the IESO to keep the deferred costs of the Fair Hydro Plan off the government's books?
4. Did the IESO initially prepare its 2016 financial statements, not recognizing regulatory accounting and later revise them?
