Hello everyone!

Now that the Board meeting has taken place and Corporate Services is gearing up to prepare our 2018 Business Plan, it is time to begin thinking of the strategic outcomes that we anticipate accomplishing in 2018. We have put together a template to capture these outcomes from across the organization, and we'd like each of you to work with your respective groups to populate the 2018 outcomes (column F in the attached). Hopefully many of these will be the logical middle point between the 2020 strategic outcomes that we have already identified and what is expected for 2017. Some points;

- We have not specified business units responsible for each outcome, as many could have multiple contributors. We'd encourage you to consider what your group may be able to contribute to each.
- If thinking of the level of detail needed- look to 2017 as a guide.
- Some of the 2018 outcomes are carried over from 2017 where these made sense - they should still be reviewed and in some cases need numbers to be updated.

We figure that this might be easiest done by deferring to each of you on this- but if you think it would make sense to have us involved, or if you think a group meeting might be useful, please let me know. We do have a new person on our team- Katelyn Margerm who will be helping me put this together, so please copy her in your responses, your initial drafts by April 5 please. Would be happy to talk more on this if you want- please reach out to either of us.

On another note- Darryl and I are in the process of establishing an internal team to collaborate on initiatives that support sector transformation. The concept stems from some specific issues we've covered in the sector in the process of putting together the Reading of the World (i.e. there are different groups looking into block chain technology and transactive energy). We want to form this team and make them responsible for contributing to some form of regular report (or space on the Hub) that can be communicated across the organization. Currently, we've reached out to the following- but this is meant to be an open group so please let us know if there is anyone else you think would be interested (or if you want to be a part of it yourselves).
