I've suggested one change in the memo to indicate the changes require legislative and regulatory change in order to be implemented. We don't want to be found to be in contempt of the legislature by presuming the legislation will pass.

Regarding risks, there seems to be reputational risk. Is the accounting/liability issue worth identifying?

On the presentation, I've proposed some changes in green, to differentiate from Jeannette's red text. I added a slide on arrangements with OPG rather than regulation changes. I'm fine if you don't want to include it but it seemed to round out the story.
