Subject: RE: Ontario Fair Hydro Plan

Please see attached the IESO/Stikemans mark-up, together with a black line to the last version circulated by the Ministry.

This draft is still being reviewed by KPMG and is subject to their comments especially around the requirements to be met in order to recognize and de-recognize the regulatory asset.

While not reflected in our mark-up, we think that Part III with respect to the billing and collection of the Clean Energy Adjustment would benefit from a reorganization. First, it might be moved later in the statute, after both Part V with respect to the Regulatory Asset and Part VI with respect to the Investment Asset. Its current placement suggests that it is relevant to both the regulatory asset and the investment asset, which is not the case. Second it might be internally reorganized so that it deals sequentially with the following subjects:

1. Determination of the amount of the Clean Energy Adjustment, which in our view should be done by the Financial Services Manager (currently in Sections 10(1) and 10(3)).

2. Determination by the OEB of the rate necessary to recover the Clean Energy Adjustment (currently in Section 10(2)). It is not clear to us that there is a role for the IESO in between the OEB and the electricity vendors, but happy to discuss.
3. Obligation of electricity vendors to invoice (Section 12)
4. Obligation of consumers to pay invoice amount (Section 8)
5. Obligation of electricity vendors to collect and remit (Section 12(2) to 12(6)). We need to provide for the collection standard and in particular make clear that they do not guarantee collection from customers.
6. Obligation of IESO to collect and remit (Sections 11(2) to 11(5)). We need to provide for the collection standard and in particular make clear that we do not guarantee performance by the electricity vendors.

All - Please find attached the draft "Intergenerational Fairness in Hydro Rates Act, 2017". A tremendous amount of work has gone into getting to this draft and much more work is required to get this ready for the House. The goal of sharing this document now is to further the process we have engaged in over the last weeks. In the attached, we have included notes to try to address where the drafting is not yet consistent with our thinking. These notes are neither comprehensive nor complete. They are intended only as flags and as colour to the draft. We have not forgotten the comments that you have already provided and we are continuing to working through the translation of the commercial terms we have been discussing into legislative language.

For ease of reference, included with the draft bill are the partially updated Blakes' summary, a chart that attempts links the articles in that document to the sections of the bill (which is imperfectly numbered at best) and excerpts from the Electricity Act and the Ontario Energy Board Act, related to the consequential amendments.

In your review, please focus on the broad stroke concepts, rather than the minutia, and keep in mind the cascade of instruments that will be required – legislation first, then regulations and finally commercial agreements. We look forward to discussing the broader concepts on Monday
