Thanks for your note.
I believe there is a meeting tomorrow between Anthony and OPG (Matt and Stu) to continue to map out the business process. This business process will form the basis for a term sheet which should be used to develop the agreement between IESO and OPG/Trust. Lets wait until we get the business process and term sheet sorted before we get all the lawyers involved. My experience is that bringing them in too early can both slow the process down and result in higher legal bills.
