OEB Convenes Net Metering Consultation in Advance of New Rules

On May 25, the Ontario Energy Board issued a letter convening a "Net Metering Consultation." The Net Metering Consultation is intended to explore the implications of the updated Net Metering Regulation (which will come into force on July 1, 2017), and to determine what changes should be made to OEB rules and processes to support the expansion of net metering.

Ontario's Financial Accountability Office Finds That "Fair Hydro Plan" Has a Net Cost of \$21 Billion

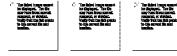
