Conservation

- The conservation memo provides an update on:
 - the 2016 verified results – demonstrated continued collaborative relationships between the IESO and LDCs to collectively reach (by end of 2016) 38% of our overall target of 7 TWh under the CFF – there is a further breakdown of the numbers in the posted memo
 - Direction re Province-Wide programs and Home Assistance Program delivery
- Provide a verbal update on IESO support in Green Ontario Fund / Climate Change – interaction with conservation

Smart Metering Entity

- The memo is an update on the work underway with the Data Strategy Advisory Council. Incorporating feedback from SAC at the last meeting, this Council was established to provide input on the design of the third party access implementation plan to the data within the MDM/R.

- This collection of data represents smart meter data of residential and small business customers.
 - A broader stakeholder engagement initiative is expected to launch in early September to provide stakeholders with input on the Plan before it is finalized
 - Sorana is here to answer any questions
- The memo also provides information on the new SME fee application to the OEB

2017 – 2019 Business Plan – Revenue Requirement Submission - Update

- The OEB issued its final issues list on the IESO's 2017 fees case on August 4th, laying out the scope of the regulatory proceeding.
- Interrogatories on the IESO's evidence were received on Thursday and the IESO has until September 7th to file our responses.
- The Settlement Conference is currently scheduled for September 14 – 15 but may be rescheduled to allow for the filing of intervenor expert evidence.

Notes for Terry:

- *RRS – Submission Details*
 - *The IESO filed its 2017 Revenue Requirement Submission with the OEB on April 21, after receiving the Minister's approval of our 2017-2019 Business Plan at the end of March.*
 - *In its application, the IESO is seeking Revenues of \$191.4 million, \$190.8 of which are to be recovered through usage fees. These revenues include funds to support the IESO's Market Renewal Program, something the Minister of Energy specifically asked us to include in our Business Plan.*
 - *We've proposed new usage fees of \$1.2187 for domestic customers and \$0.9872/MWh for export customers, increases of approximately 4.7% and 2.8% respectively.*
 - *(Note: current fees are \$1.1636 for domestic and \$0.9603 for exports)*
- *The OEB is allowing parties to file expert evidence. If parties intend to do so they are required to inform the OEB by August 25 and provide the estimated costs, including assumptions regarding the participation of the expert in the proceeding and incremental time that will be spent by the intervenors counsel or any other consultant(s) in relation to the expert evidence.*

2018-2020 Business Planning Process

Long Term Energy Plan Update

- Ministry of Energy is expected to release Long Term Energy Plan in the Fall
- At the same time, Ministry will issue an implementation directive and an amending direction for several past IESO-directed initiatives
- Following the release of the LTPEP and implementation directive(s), the IESO (and OEB) will submit an implementation plan to the Minister for approval

- *Implementation plan due to the Minister by December 31, 2017*

Regional Electricity Forums

- The IESO is conducting five regional forums across the province – one in Thunder Bay, Sudbury, Ottawa, London and Vaughan – these forums are designed to broaden the dialogue on electricity issues across the province on a more local level - The dates and other details about the meetings are in the materials
 - We invite any suggestions on local agenda topics or local speakers – as well as your support in outreach efforts if you belong to any of these communities
 - We are looking forward to hear from Michael Cleland later in the meeting on the Univ of Ottawa's research within the Positive Energy project – and, in particular, what he is hearing from people across the country on what is needed to effectively engage communities in decision-making within the energy sector

Stakeholder and Community Engagement Update

- *The Board will review all candidates and we expect they will appoint new members before the end of October*

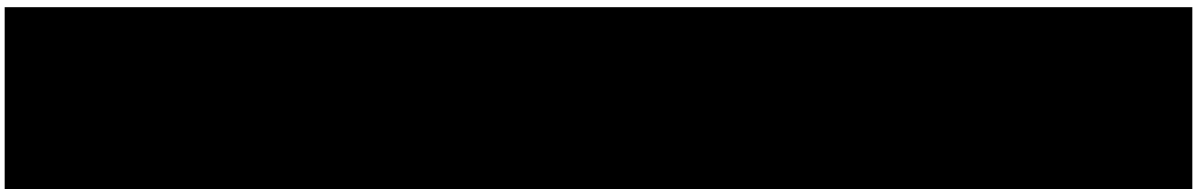

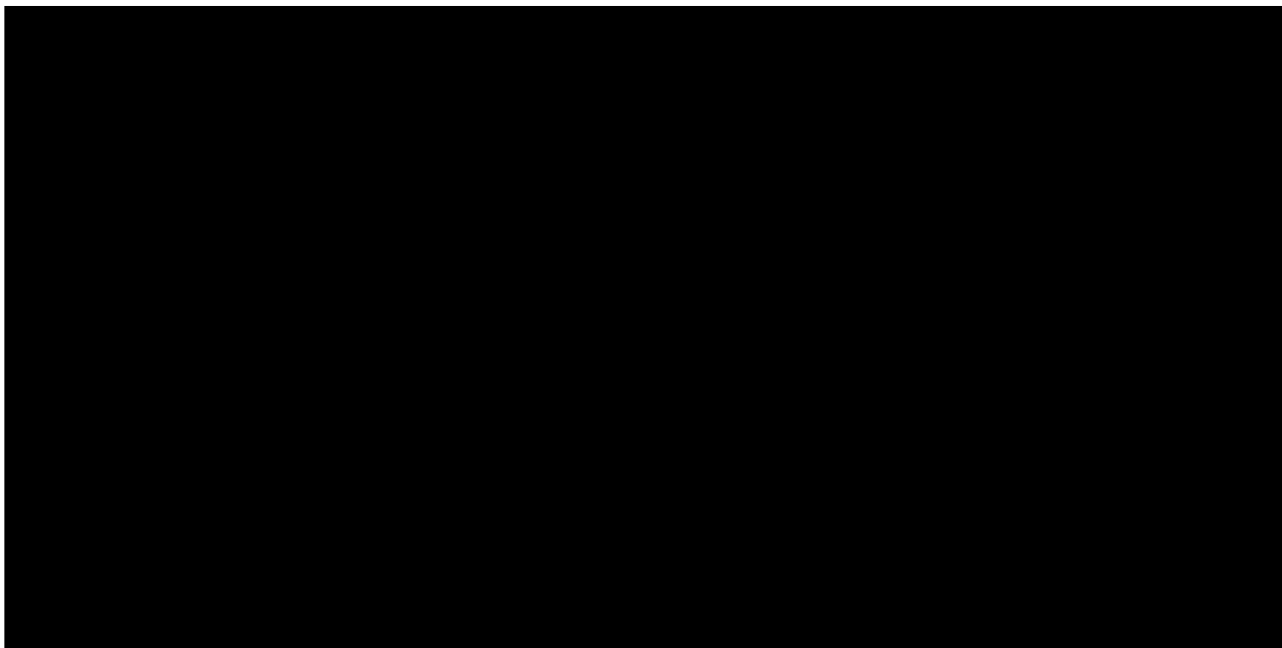
