Good morning, Michael. We are pleased to attach the next consultation draft for the proposed General Regulation which, if approved, would be made under the OFHPA.

Please note that Legislative Counsel, due to drafting practices, has removed some of the definitions. They were creating some confusion. Legislative counsel's intention was to communicate concepts in a more direct fashion, particularly about the relationship between various types of "amounts" and "the period of time" in which they are (or are to be) paid or received.

In many cases the substantive provisions themselves elaborate the principles previously provided for in the definitions.

Please provide us with any comments you may have as soon as you are able, as we're now in the final stages of drafting.
