Hi everyone,

See my comments and suggested edits below – let me know if you have any questions or concerns:

- Slide 2, 1st bullet – comment: Establish short form for MOECC as well, i.e. Ministry of Environment and Climate Change (MOECC).
- Slide 2, final bullet – edit: “Given significant decarbonisation of the electricity grid and relatively high prices of solar systems compared to conservation and energy efficiency measures, a solar rebate program may cost more to reduce Ontario GHG emissions than other potential measures.”

- Slide 5, final bullet – comment: Stating that microFIT is transitioning to net metering in 2018 may imply that the IESO has a role to play, when it does not.
- Slide 9, title – edit: “Electricity system considerations – capacity and energy is currently in surplus, so near term addition of Solar PV will exacerbate these energy and capacity levels”.
- Slide 10, 1st bullet – comment: Do you mean to say “electricity rates may change under the program”. You may want to consider revising final sentence to read as “Additional funding from the GOF may be required to mitigate against rate increases for electricity consumers.” Please note that I do not know to what extent rates would be impacted in near term given the Fair Hydro Plan.
- Slide 10, 3rd bullet – edit: “Also, as time progresses, decreasing costs and improvements in technology performance of PV is expected to provide more value for future investments.”
- Slide 10, 4th bullet / Slide 11, 2nd bullet – comment: Does this align with recent discussion with Planning? GOF may ask for additional information regarding which regions of the Province are constrained.
- Slide 11, 1st bullet – comment: Do you mean “home heating and cooling”?
- Ensure consistent spelling of “decarbonisation” vs. “decarbonisation”.
- All instances of GreenOn should be revised to “GreenON”.
- Slide deck to be marked “IESO Confidential”.

Evelyn, please advise who else from the IESO will be joining you at the October 4 meeting with the GOF/MOECC?
