Let's play it by ear. We should be receiving a revised MTSA from Torsys/Oslers early this week, following the large group meeting we had with them last week.

At the meeting last week with Torsys/Oslers/OPG/Dealers, they seemed to accept that IESO would not have an enforcement or collection agent type role. They would like IESO to engage in some level of information collection/review/reporting to identify discrepancies or potential issues and follow up with LDCs about issues. They also want to receive forecasts from IESO. We indicated our discomfort providing forecasts to anyone other than OEB.

The other big issue we need to land is priority security during moratorium period. We indicated we were still performing due diligence and that IESO board would need to approve, so we could not commit to providing it at this stage. This does make OPG nervous as this is a rating agency issue.
