Hi John. I believe Anthony will be touching base with OFA on certain issues. Separate from that, in terms of the status of the documents, this is where things currently stand as I understand it:

(i) On Friday afternoon, I sent back to OFA a markup of the draft FHP Credit Agreement, mostly to conform the Intercept language in the Credit Agreement with that in the Intercept Letter itself - so we will need to see a revised version of this document;

(ii) Intercept Letter - I understood that there were still some internal reviews going on concerning the most recent draft, so I am not sure if we have seen a final version of this document;

(iii) Existing Credit Agreement - we have not received a revised version of this agreement showing the insertion of the Intercept language and the additional permitted liens language - I understand that is expected to be available soon.

For further certainty, the OFA and ENERGY acknowledge and agree that the intercept provision as provided for herein, and this letter agreement generally, shall not apply with respect to any funds appropriated by the Legislature for payment to the IESO through ministries other than ENERGY or through Ontario Climate Change Solutions Deployment Corporation.
