Hi Les,

The trigger for intentionally engaging in market activities would be if the Trust applied to participate in any of the markets established by the market rules. Once registered in Online IESO, the Trust would be able to request through Online IESO to participate in IESO-administered markets like the Transmission Rights Market. Upon such request Market Entry staff would verify that the Trust has an MP ID, banking information, signed participation agreement, contacts info and if required necessary prudential. In other words, once registered in the system, it is possible to request and be granted access to other IESO Administered Markets. The concern is that the Market Entry may not confirm that the correct participation agreement was actually entered into. Because the program agreement being used for the Trust is a non-standard approach of the IESO, it is likely Market Entry would not know to look behind the existing registration.

Hi Les,

I understand you are off site today, but it would be good if you had 5 minutes for you and I to discuss this agreement.

This agreement needs to be completed in order for the Fair Hydro Trust to register as a program participant in Online IESO. The agreement and approach the IESO proposed is an approach which already differs from the IESO's standard approach. We proposed this to address the concern that was raised with having the Trust sign the participation agreement. The IESO understood that concern and proposed an alternative that would only require the participation agreement to become active if the Trust intentionally engages in an activity in the IESO-administered market.

The issue seems to come down to Torsys not wanting to have the Trust become bound by the participation agreement if the Trust engages in an activity that would have required execution of the participation agreement in the first place. Agreeing with IESO's approach seems very low risk since it is entirely within the Trust's control to not engage in market activities, and there is no reason for it to do so. The agreement is drafted so that the Trust would need to intentionally engage in this activity in order for the participation agreement to become active.

On the IESO side, this arrangement is important as it is an auditable control measure and as such is the basis for which we obtained the approval of our market entry team to this non-standard approach. It could take us a week or more to change this approach internally and there is no guarantee a change will be agreed to.

Torsys proposal of the remedy being to terminate the program agreement is not practical because IESO and Trust will continue to need to use Online IESO to effect settlements for Fair Hydro.

I'm hopeful we can take the pragmatic approach and move forward with the agreement as the IESO has proposed. Alternatively, we need a clear indication of the concern so we can try to address it within the framework of the proposed approach.

Glenn - Please send the intended attachment. It was not included in your email this morning.

Though I will comment more fully once I see the revised draft, the work-around approach, as I discussed with you previously, contemplated using the side agreement in place of the standard form PA. We never agreed to the PA becoming triggered by anything under the side agreement for the very same reasons we determined not to use the PA in the first instance. Having the consequence of a breach under the side agreement be that the PA is triggered is inconsistent with the agreed-upon need for and use of the side agreement.

We have reverted to the previous draft whereby the issuer would be bound by the PA if it "intentionally" participates in the IESO-administered markets. This was the compromise/work-around approach we had initially proposed and which we got internal IESO approval on. The IESO is not agreeable to OPG's proposed change - Michael Boll I understand may call Les Wong about this later today. I would not think that this poses any real risks for OPG since the PA is only triggered if the issuer intentionally uses its access to Online IESO to participate in the market. In answer to your questions:

- With regards to what information needs to be exchanged by IESO/Issuer via Online IESO under the MTSA - carrying cost will be submitted monthly for payment; the portal allows for a secured mechanism to submit costs that can be machine read and transferred to an invoice for payment.

- With regards to what confidential information Issuer would gain access to - it is a secured site and Issuer is only be able to access its own confidential information, i.e., banking info, address, submitted data, etc.

- With regards to whether other Online IESO participants will have access to any confidential information of the Issuer - as a secured site, other participants will not be able to access confidential information of the Issuer.
Please get back to me ASAP with any suggested changes. I understand that this needs to be completed and the Trust registered in Online IESO promptly in order to be able to complete the scheduled transfers.
