The "Variance" amount associated with the **Fair Hydro Plan** for May 2018 posted on IESO's website was very large and led to a query to them as to why it was so high. These monies associated with the 25% break on our electricity bills are being accumulated by borrowings by the province/OPG over the next four years and will start being recovered from all ratepayers starting in 2022. The concern is the dollars being shoved forward don't bode well for future electricity bills as they appear to be in excess of the forecast.

My query to IESO got an explanation most rational people would consider "over the top". In turn it resulted in my trying to come to some logical conclusion that ratepayers are being protected by them. IESO are responsible for all financial settlements associated with managing the grid and execute payments to generators, transmission companies (Hydro One) local distribution companies, etc. and all of the dollars connected to the **Fair Hydro Plan**.
