Attached, you will find the first of two requests for the creation of new charge types related to the settlement of the Ontario Fair Hydro Plan (OFHP). This request concerns three new charge types that will be settled for the first time on the May 31, 2017 PSS. Please assess the tax treatment for each charge and return the completed form to me by Wednesday, May 24, 2017. I will be submitting a separate request for more new charges to be settled for the July month-end.

When the tax assessment is completed by Finance, the next steps will need to be completed by Wednesday, May 31, 2017 :

Next Steps:

1. Authorization of Form 1137 by Settlements and Finance.
2. Creation of new charges in Lawson by Finance.
3. Creation of new Group Code 65 in Lawson by Finance.
4. Verification of Group Code and charges 2470, 1142 and 1192 in CRS by Settlements
5. Application of tax treatment in CRS by Settlements
