Hi Susan,

The difference is due to timing. There will always be a one month lag between our number and that of Settlements. For example, they report July charges under July. However, on the finance end July charges are invoiced in August and that is when it is recorded in the GL because the movement of cash is happening in August. If you prefer, I can book an accrual each month to align with settlements.

Below, I have added the July amount invoiced in August to the GL balance as well as included a copy of the invoice. There is a \$3M variance between the 2 numbers. I will be touching base with settlements to inquire what charge types they are including in their number.
