Alefiya – Market Accounting:

Attached please find FORM 1137 containing the following new charges and a new group code that need to be created for the settlement of the Ontario Fair Hydro Plan (OFHP) as it pertains to the regulatory asset. The tax treatments are based on the tax assessment provided to Yan Bechamp (email attached) by Finance. Please verify the tax treatments as applied correctly in the form.

If there are any issues, please let me know. I will bring Form 1137 up to you to obtain the appropriate sign-offs next week. When you have added these new charges into the financial system (aka Lawson), please let me know so I may update the tax treatment information in CRS. These charges are monthly charges, effective November 1, 2017, so we need to have them in place by the end of November at the latest.
