Based on today's TP discussion around the confusion between "regulation ancillary service" and "regulation based settlement" we have revised the market rule amendment submission document. As suggested by Sarah Griffiths and Bill Wilbur we have changed the title, added a sentence to explain that this refers to settlement amounts resulting from regulation, and have replaced "regulation based" throughout the document.
