Guy Holburn is a Professor of Business, Economics and Public Policy at the Ivey Business School, University of Western Ontario and is the founder and Director of the Ivey Energy Policy and Management Centre. George Vegh is head of McCarthy Tétrault LLP's energy-regulation practice, teaches energy regulation of the University of Toronto, and is the former general counsel at the Ontario Energy Board.

We will discuss important issues raised by Fair Hydro Plan detractors and supporters such as its long-term impact, alternatives, Ontario's electricity sector governance, and the public policy challenges that underlie these questions. The conversation will be moderated by Héloïse Apestéguy-Reux and Kerri Lui, both lawyers in McCarthy Tétrault's energy group.
