Input invited on Indigenous Conservation Programming Report

The IESO is seeking input on the development of a draft Report intended to provide options to improve future conservation programming for First Nations communities and Métis in Ontario.

A webinar will be held on Tuesday, December 19 at 10:00 am to present an overview of the input received from First Nations communities over the fall and how that input will inform the draft report as well as proposed recommendations to improve future program offerings.

This webinar will provide all interested parties with an opportunity to offer input for consideration into the development of the Indigenous Conservation Programming Report. Interested parties must register to participate in the December 19 webinar.

The Report is being developed in response to one of the Implementation Directives following the release of the Minister of Energy's Long Term Energy Plan and is intended to inform the Conservation Framework Mid-Term Review in early 2018.

Single Schedule Market Meeting: December 11

Market and System Operations

Baseline 38.1 now published

Baseline 38.1 has been published. The changes in this baseline were communicated through the plan and review process, and feature amendments to the market rules as well as revisions to manuals and supporting documents. These are available on the Market Rules and Manuals Library and Technical Interfaces web pages, respectively. Documents have been updated to include the settlement of the new programs under the Fair Hydro Act, 2017.

Three documents (*Charge Types and Equations*, *Market Manual 5.5 - Physical Markets Settlement Statements* and *Format Specifications for Settlement Statement Files and Data Files*) have been updated to include the settlement of the new programs under the Fair Hydro Act, 2017. The *HST Guide for IESO Transactions* will be published in the near future.

All document changes can be found in the Guide to Documents Published in Baseline 38.1. The baseline is a formal process to revise Market Manuals and related documents that result from recently approved market rule amendments or technical system changes.

The IESO thanks all stakeholders who provided feedback into the Baseline process.

Pre-implementation review as part of Market Information System refresh project completed

As part of the Market Information System (MIS) refresh project, the IESO engaged an independent consultant to perform a pre-implementation review to verify compliance with the market rules.

This comprised a review of the day-ahead calculation engine and the real-time algorithm used in the Ontario electricity market.

The result of these reviews concludes that there are no reportable findings that may impact the IESO's ability to comply with our market rule obligations. The full reports are available on the [Public Information Sessions](#) webpage.

Program Update

microFIT Program Application Window Closed

The microFIT Program reached its 50 MW annual procurement target for 2017 on December 1. As a result, the IESO has officially closed the application window for the microFIT Program and will not be accepting any further applications.

Applications that were submitted on or before December 1, 2017, will only be reviewed if capacity becomes available by December 29, 2017. Applications that have been set to Pending LDC Offer to Connect status by December 29, 2017, will continue to be processed in accordance with the microFIT Rules. Applications that have not been set to Pending LDC Offer to Connect status by that date will be terminated.

Per the direction issued by the Minister of Energy on [April 5, 2016](#), the IESO is required to stop accepting applications under the microFIT Program by December 31, 2017, and the direction set the Annual Procurement Target at 50 MW.

The IESO thanks everyone for their interest and participation in the microFIT Program. Since it began in 2009, more than 26,000 contracts have been awarded to microFIT participants, representing over 230 MW of renewable energy. Those interested in small-scale renewable generation may consider contacting their local distribution company to determine if there are any net metering opportunities in their area.
