Re: Treasury Update

The following are key updates for your information.

On November 8, 2017, the IESO and the Ontario Financing Authority formally entered the \$2 billion line of credit utilized for the Fair Hydro program.

As of November 21, 2017, the IESO had \$1.0 billion drawn on its debt facilities for the Ontario Fair Hydro program. The estimated monthly amount to be incurred going forward will vary but is expected to be approximately \$200 million per month.
