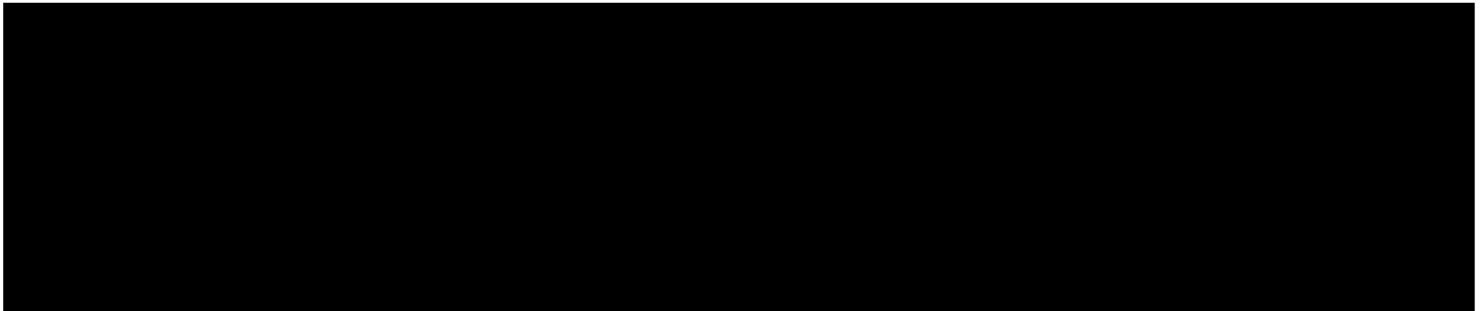
Subject: Reminder to identify and submit internal documents changing for Baseline 37.1 - June 7, 2017

April 3 - 28 is the notification and redline document submission period for internal documents changing for Baseline 37.1.

If you are revising, adding new, making obsolete or superseding a document please do the following:

- Notify IESO Baseline Management (BM) of document revisions using the 'Baseline Registry' tool on the Baseline Management webpage.
- Notify BM even if your document is not ready for posting, this includes documents/forms made obsolete or superseded.
- Your revisions are communicated within the IESO through the Internal Baseline Plan.
- Provide redline revisions to Baseline Management no later than **Friday, April 28, 2017**.
- Documents are posted on the internal Pending Changes page for review and impact assessment.
