> Just want to clarify that there is no formula error (Form 2G, cell C22 was designed to be formula driven and protected by central agencies). The reason 2016-17 opening accumulated operating surplus/(deficit) on IESO's 2016-17 PA OGO template (Form 2G, cell C22) does not agree to prior year's closing is because amounts entered by IESO in 2016-17 PA OGO templates are NOT consistent with those reported by IESO during 2015-16 PA.
