Both of these charge types can fluctuate but for the month of May they did for two separate reasons.

CT 150 can be largely attributed to the fact that energy and OR prices were much lower in May than April HOEP was \$3.17 vs \$11.14 in April and OR prices were \$5.28, 8.23 and 1.47 for 10 spinning, 10 non-spinning and 30 min OR vs \$15.83, 12.09 and 7.95 in April.

The large change in CT 192 is most likely the result of the Ontario Fair Hydro Plan.
