A new rate for the RRRP program under the FHP was effective July 1, 2017. The balance in the RRRP variance account to June 30, 2017 was \$6,626 thousand. The new rate has resulted in an under collection of \$4,017 thousand in the third quarter for the RRRP settled through the market accounts, resulting in balance in the variance of \$10,643 thousand as at September 30, 2017.
