Under Ontario Regulation 515/17: Invoicing Requirements, we need to update how we inform [REDACTED] of their rebate on their invoice with respect to the Ontario Fair Hydro Plan.

The IESO, along with their invoice, will need to issue an email to [REDACTED] which states the following:

“Ontario’s Fair Hydro Plan saved you \$ [REDACTED] on your bill. This includes the 8% Provincial Rebate.”
