The next step will be for the Ministry of Energy to get the regulations that support the bill through the Legislation and Regulations Committee ("LRC") process, ultimately to be approved by Cabinet followed by the Lieutenant Governor-in-Council. It's likely that the Ministry will want this process to be complete before July 1.
