My regulatory accounting team, led by Dan Gopic, is considering what accounting guidance, if any, the OEB should provide to LDCs. I was wondering if you would be open to meeting with us to discuss what your plans are for the content to be communicated to LDCs and what you may be considering as formal guidance (if in fact there will be formal guidance) to LDCs.
