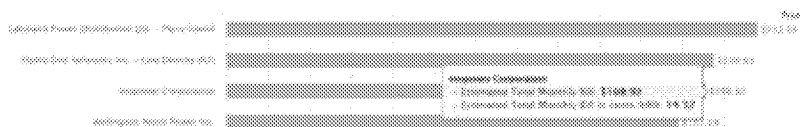

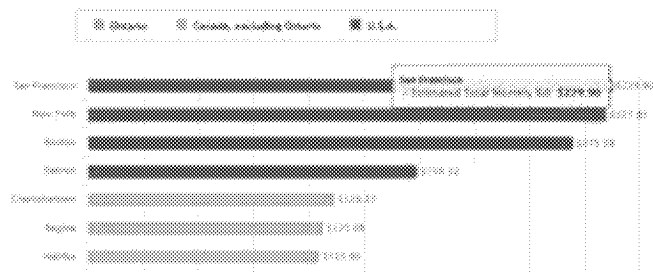

FYI - earlier this week the OEB posted an [electricity rate comparison dashboard](#)

The data compares the total electricity bill amounts of each LDC for both residential and small business (GS<50 kW) rate classes. The information is presented in a list and map format. The calculated figures are based on average monthly electricity consumption in each rate class, before taxes, and include Fair Hydro Plan adjustments.



The tool also compares Ontario's electricity prices to other jurisdictions across Canada and the U.S. The Ontario figures are based on current electricity commodity prices (November 1, 2017) for the Regulated Price Plan, time-of-use (TOU), as well as the OEB rate database, while data for jurisdictions outside of Ontario is based on the 2017 Hydro-Quebec Report.
