We have been in discussions with the OEB to seek further clarification on an interpretation of the *Ontario Rebate for Electricity Consumers Act, 2016* (ORECA) that the OEB provided to one of our market participants, [REDACTED] and that is used by LDCs.

The OEB's broad interpretation of ORECA is that the 8% rebate is applicable to the entire bulk metered electricity consumption for a university complex that also has a residential complex located on it. This is inconsistent with how we have applied ORECA where it would only apply to the portion of the electricity consumption related to the residential complex. As well, the ORECA electricity consumption is the eligibility basis of the *Ontario Fair Hydro Plan Act, 2017* (OFHPA) Global Adjustment Modifier for non-RPP consumers.

- If using the OEB's interpretation, [REDACTED] would be eligible for a rebate of \$762,000 for the application of the 8% (ORECA) and \$1,648,000 for the application of the GA Modifier (OFHPA) while under the IESO's interpretation, [REDACTED] would be eligible for a rebate of \$18,800 for the application of the 8% (ORECA) and \$37,200 for the application of the GA Modifier (OFHPA).

Given that ORECA is an enforceable provision under the *Ontario Energy Board Act, 1998*, we've decided to defer to the OEB for the interpretation on the application of the 8% rebate. However, we need it formally documented before making any changes to the settlement of [REDACTED] account.

I hope you are well. I'm writing to raise an issue and initiate a discussion regarding the interpretation of the *Ontario Rebate for Electricity Consumers Act, 2016* (OREC), specifically as it relates to university campuses on which a residential complex is located.

Dear Anna Fitzpatrick,

This is our response to the enquiry you submitted to Industry Relations.

Specifically, you were asking about qualifying for the OREC 8% rebate.

In addition to the qualifying criteria of using less than 250,000 kwh a year or having a demand of less than 50 kW, an account can also qualify for the rebate if it relates to a residential complex like an apartment building or a condominium. If it is a residential complex it can have usage higher than the 250,000kwh or 50kW demand limits.

If you have a bulk metered account that even partially relates to a residential complex, then that account should qualify for the rebate. The rebate would apply to the entire bill amount, even if the majority of the bill relates to non-residential load.

Thank you for your enquiry. I hope you find this information helpful.

Under OREC, a consumer that has an eligible account is entitled to an 8% rebate on its bill.

Under OREC, "eligible account" means, in respect of a consumer, an account with an electricity vendor, or with a person prescribed by the regulations, for the provision of electricity in Ontario if, [...]

- (d) the account relates to,
- (i) a dwelling,
 - (ii) a property, within the meaning of the Condominium Act, 1998,

(iii) a residential complex, within the meaning of subsection 2 (1) of the Residential Tenancies Act, 2006, without regard to section 5 of that Act, or
(iv) a property that includes one or more housing units and that is owned or leased by a co-operative within the meaning of the Co-operative Corporations Act, or

The IESO's interpretation of OREC is that the rebate would not apply to the invoice for the entire bulk metered electricity consumption for a university campus that also has a residential complex located on it. As an example, a residential complex may represent a small portion (e.g. 4%) of the total campus' load.

The interpretation of an eligible account under OREC would also apply to the definition of a "specified consumer" under the Fair Hydro Plan Act, 2017. If the expansive interpretation expressed in the OEB email above were applied, an entire university campus' electricity invoice amount would be eligible for the fair adjustment under Fair Hydro.

It has been suggested to the IESO that this expansive interpretation is currently being used by all LDCs across Ontario for this specific subset of consumer.
