A few comments/additional requests on the energy managers deck. Could IESO aim to send back a revised version on Monday?

1. The amending direction asking OPA to deliver an energy manager program was issued October 23, 2014, and the Ministry is hearing strong interest from businesses and business associations in energy managers. It is important that the Sector-Based Energy Efficiency Program be in market in Q2 2017, and that IESO take steps to reach small businesses (as established in the direction).
2. There are a few outstanding pieces of information we were hoping to have addressed in the deck:

The deck should also be a little bit of a 101 on Energy Managers, should give a good picture of the process from a customer point of view:

- *Can a customer can I hire its own Energy Manager and get funding from the IESO? If so, what is the process?*
Not currently addressed. Slide 6 describes that the funding flows to the company that hires an energy manager, but does not describe the application or hiring process.
- *Do LDCs have in-house Energy Managers that are 'loaned-out' to customer sites?*
Not currently addressed. Should be explained that IESO or LDC does not hire energy managers, customer must hire, and a bit on how this works, who are eligible energy managers/how a customer finds them.

· Does the IESO have Energy Managers on contract that are 'loaned-out' to customers through an application process?
