An update on yesterday's shoot—

Overall I think the video shoot went well but some things to note:

The minister delivered prepared remarks, which I thought he delivered well, albeit a bit “politician like” but well delivered nevertheless.

The minister thanked Bruce for his efforts on the following:

- The Ontario- Hydro Quebec capacity exchange agreement
- The development of the OPO
- His help with the development of the Fair Hydro Plan
- Delivered some kind words about Bruce (i.e. his work ethic as well as Bruce's influence on the minister. He called Bruce “dynamic.”)

Bruce delivered prepared remarks thanking the OEA for the award.

The videographer also asked what he'll miss most about the sector and what he plans to do during his retirement. The videographer also asked if he had any words of advice for his successor, which is where I thought Bruce felt uncomfortable. After Bruce left, I told the videographer that we'll likely have to cut that out of the video as I could tell Bruce was a bit uncomfortable and that it may not be appropriate to include. They were okay with that.

I will check to see if the production team can provide clips of yesterday's shoot today. They have committed to sending us a draft of the video by Tuesday, which will incorporate the interviews, Tim's audio recordings and photos.

We will have the opportunity to review and provide feedback of the draft video before it goes for final edits.

- The video production team has been selected. Name of the company is called Goody Cambay.
- Filming times have been confirmed.
