Dear Madam:

We write in connection with our letter to the Independent Electricity System Operator (the "Company"), dated May 16, 2017, regarding our accounting opinion on the application of Public Sector Accounting Standards to the consolidation of a trust and to the recognition and derecognition of a variance account in relation to the Bill 132, *Ontario Fair Hydro Plan, 2017* as tabled in the first reading (the "Bill 132") (the "Document"), that was prepared pursuant to the terms of the engagement letter dated April 27, 2017 (the "Engagement Letter"). Any reference to the Document in this letter will refer to either a draft or final version of the Document.

KPMG LLP ("KPMG") understands that the Ministry of Energy (the "Ministry") has requested that a copy of the Document be provided to them, and that the Ministry may wish to make the Document public. For purposes of this letter, the term KPMG shall include its subsidiaries, its associated and affiliated entities and their respective current and former partners, directors, officers, employees, agents and representatives. This letter shall apply regardless of the form of Claim, whether in contract, statute, tort (including, without limitation, negligence) or otherwise.
