All,

Quite a bit of progress has been made on the LTEP front this week, please see below for next steps before next Tuesday's internal WG meeting.

Firstly, a shared folder has now been established: \\aspen\workgroup\Internal LTEP WG\. Please ensure relevant materials are saved here. Please also ensure ministry requests are kept up-to-date in the requests tracker. You'll note that a new request has come in, asking the IESO to update the OPO basecase to include any new policy developments (such as the suspension of LRP II) – a meeting will be held next week with ministry staff to discuss assumptions.

Next, the IESO attended the first two meetings, covering 6 of 12 proposed LTEP Themes. Meeting materials are attached again for reference and are also saved in the shared folder. Please note sensitivity and use discretion if forwarding on.

Attached you will also find a spreadsheet that attempts to summarize all of the ministry's recommendations from these 6 decks, and the discussion that took place with Minister's Office this week. An indication of what will be included in LTEP, based on MO preference, is included in the "Notes" section. This spreadsheet is also saved to the shared folder and will be updated as the remaining 6 "LTEP Themes" are shared.

ACTION: please review the "Summary of Ministry Themes Meetings" document before next Tuesday's internal WG meeting – this document will be the focus of that discussion. Specifically, we'd like you to provide your comments or flag any concerns/issues with what is being proposed, so that we can determine next steps for government engagement. Ministry staff will be meeting with the Minister next week to walk through all of the recommendations; ideally we'd like to have our input into the ministry before that meeting with the Minister takes place.
