Subject: LTEP briefing schedule and IESO next steps

Mike, Terry,

Below is the most recent LTEP briefing schedule. Note, we have been asked to lead a few of these briefings and details on those are also included below.

The first is a Minister's briefing on the current modelling for Thursday next week. Ministry has asked that IESO develop a deck that is a cross between the initial deck submitted, and the one from last week that included options for reducing system costs. We have been asked to submit a final deck by end of day **Monday, June 12.**

The next product is for the June 20 briefing with MO. In preparation for the June 26 briefing for PO, MO is hoping to have a product that outlines modelling and background assumptions on the demand outlook – because conversations are ongoing on supply, ministry intends to focus on demand only. We have been asked to submit a final deck by end of day **Friday, June 16.**

Separately, there is a market reform briefing scheduled for PO on June 20. A product for that is tracking for **June 14.**
