Hi Anthy,

As discussed, below is the most recent LTEP briefing schedule that IESO would be involved in. There are a few upcoming briefings that would be an IESO lead.

The first is a Minister's briefing on the current modelling for Thursday next week (June 15). We envision this being a bit of a cross between the initial deck you submitted, and the one from last week that included options for reducing system costs. The story we want to tell the Minister is here is what the system would look like with no intervention (supply, demand, costs), and if we wanted to bend the cost curve, here are some options. If you have any questions about the

product, happy to discuss tomorrow morning, or when you're here for the briefing. Could you share a deck for **Monday next week**?

The next product is for the June 20th briefing with our MO. In preparation for the June 26 briefing for PO on demand, our MO is hoping to have a product track in for a June 20th briefing for discussion. We want to give PO an update on our modelling, and background assumptions, on the demand outlook for LTEP. Since supply is somewhat in flux at this point, we'll just focus on demand for that briefing. Could you share a deck for that briefing **Friday June 16**? We can regroup on timelines should another version of the deck need to be turned before the PO briefing.

I sent David (copying you) a separate email on the market reform briefing for PO scheduled for June 20th. In case it's helpful to have the due date for that product in this email as well, so you have it all together, it would be **June 14th**.
