Subject: Changes to IESO reporting related to OREC Portal Changes

Hi Susan,

Following up on our call earlier this week, here's additional information we need from the IESO regarding the Ontario Rebate for Electricity Consumers (OREC). Could you please help us set up a meeting with IESO settlement/reporting team to discuss?

The Ministry needs the IESO's support to update the Ontario Rebate for Electricity Consumers submission window in the IESO's Market Participant Portal, in order to collect more information. The Ministry needs to ensure expenses reported by IESO are accurately assigned to the particular month they were incurred, which will allow us to complete expense reconciliation and track accruals properly.

The monthly submissions from LDCs to the IESO are comprised of two components: billing for the current month, and billing for adjustments to prior months. The Ministry retrieves this data from the IESO Reports Site (<https://reports.ieso.ca/private>) via the Physical Market Preliminary Statement (Settlement Statement).

- Currently the IESO's system does not provide a detailed breakdown of any adjustments to prior month data.
- All prior month adjustments for an LDC are grouped into one line in the Settlement Statement data appearing as "Previous Month Balancing Amount". We have no way of knowing whether the adjustment expense should be attributed to the past month, or some earlier month.

The Ministry suggests that the OREC portal is updated to match the existing format of the Ontario Electricity Support Program (OESP). This will allow LDCs to breakdown their adjustments to prior months, which in turn will allow the IESO to provide the Ministry with the required data.

Please refer to the screenshot of the OESP Prior Month Adjustment submission window below (page #31 of the "IESO Guide to Online Data Submission", attached).

- The OREC portal should be updated to mimic the format and functionality of the existing OESP portal; including displaying a table to review all of the data entered prior to submitting.
- Allow current month claims to be submitted using the same window/interface. For OESP, this window was used solely for prior month submissions.
- The "Participant/Service Program Type" field should be removed as it is not required for the OREC program.

Complete the fields and then click the **Add Information to Table** button.

The bottom of the screen (not shown) lists all the data entered for the current submission window, and also allows you to delete entries.

Repeat these steps if you need to submit more than one entry. When all entries have been added, you then remit the claims by clicking the **Submit** button.

If these updates are implemented, the format of the Settlement Statement data would need to change accordingly. We have attached a mock-up of the proposed changes to the Settlement Statement, as it is retrieved from the IESO Reports Site by the Ministry.
