Attached for your review, and to assist with your consideration of proposed Market Rule amendments (which will go out to a broad internal distribution next week), please find a draft of the Detailed Design for Capacity Exports, Phase 2. Earlier versions of this document were reviewed by Senior Managers and subject matter experts and updated accordingly. Footnotes have been used to identify where issues/questions raised in those earlier reviews are currently being resolved. Your comments and the outcome of these investigations will be incorporated into the next draft.

This design is intended to cover the period from now until the implementation of Market Renewal. Changes to this design may occur at a later date to make it compatible with MRP, or to take advantage of processes/opportunities resulting from MRP.

We are hoping to send the rules to the Technical Panel on May 14. With that in mind we are happy to take comments on the detailed design until May 16 if your comments pertain to items that would not impact the rules or the overall framework of the Capacity Export initiative. Leonard has requested that the Directors examine this design as a whole and provide any necessary feedback to ensure that the described program holds together as a totality. This request is of course in addition to any comments you may have on items that impact your process.
