All,

We received a call from Peter Maloney of Utility Drive, who is doing a story about energy storage opportunities.

He had the following questions for us about global adjustment:

- How much was GA Charge in 2017, or most recent data you have?
- Does it apply to commercial customers?
- How does the Fair Hydro Act 2017 affect things?

We will provide him with the figure for the first question, and for the second we will explain what constitutes a Class A and Class B customer. We'll also mention how the IESO is enabling opportunities for storage, such as our energy storage working group that is looking at ways to remove barriers for storage.

For the third question we'll suggest the government is better suited to speak to it.
