## Media Questions:

Public accounts, they are doing a difficult job. It's not easy. It's not easy being the one waving your arm in the air saying 'excuse me there's a problem here' and that's the job but it's a tougher job than I think a lot of people can appreciate. And I think we have to think of it when the Auditor General says that the government says their pre-election report is not a reasonable presentation of Ontario's finances. That's a strong statement. It is pre-election report so it has it has it has gravitas to it. And I think one of the biggest issues is the Fair Hydro Plan. We've been opposed to the Fair Hydro-Plan interest since the day it was decided it's a policy. And I think the simplest way to explain it, from what I understood when the Auditor General explained it to us, is the government made a decision to borrow \$25 billion dollars, which could turn into \$40 billion dollars, they made that decision, but it doesn't show up on their books.

When you talk about legislative accounting, if a government makes a decision, whether it's right or wrong, we believe it's wrong and that's why we are the only party who's on record saying we are going to scrap it. We are not going continue with the Fair Hydro Plan. But when government makes a decision to spend money, it should show up clearly and transparently on the books. And in this case - it doesn't. And what makes this one even worse is because the way it shows up, it's not and it's not an issue that the money is disappearing. It's showing up somewhere else, but not clearly on the government's books. And because they've decided to borrow the money they've decided to borrow \$25 billion, and they decided to put it on someone else's books, books which they control, the interest costs are much higher because government can borrow money cheaper than the OPG.

So that's an extra \$4 billion that's going on top and who is going to pay that is the people who buy hydro in Ontario. And that's the toughest part of it [Inaudible] and why we have been opposed to the Fair Hydro Plan from day one because it's a temporary plan basically. And what the Auditor General said just a few moments ago, the government is borrowing money to the bills that the people are getting are higher than what they're paying, so the government is paying the electricity generators. That bill is going to come due. So it's not a Fair Hydro Plan, it's a temporary hydro reduction with a big bubble payment at the end. That's the problem. But getting back to the Auditor General's issue, if the government decides to borrow money or decides to implement a program, it should show up on the government's books and in this case it doesn't.
