This e-mail is a formal request for information from the Independent Electricity System Operator, to inform the Environmental Commissioner of Ontario's (ECO's) upcoming 2018 Annual Energy Conservation Progress Report, which fulfils the ECO's mandate under section 58.1 of the *Environmental Bill of Rights, 1993* to report annually to the Speaker of the Assembly on progress to reduce energy use and improve energy efficiency in Ontario.

This year's report will be taking a broader look at the results of the three "greening" initiatives of the electricity sector over the past decade: the coal phase-out, renewable energy procurement, and utility conservation programs, looking at the impacts of these initiatives on our electricity system, on the environment, and on energy prices.
