In follow up to my email below, the attached document shows the changes from the version that we provided to the ministry in late August, and the one that was provided to us by ministry last night. Changes are tracked, which can be a bit deceiving, because the document also tracks items that have been moved and not just ones that are newly added or deleted.

Noteworthy changes include:

- “Key elements” from each chapter are now included on pages 4-8
- OESP monthly credits charts on pages 13-14
- New wording in sub-section “Electricity Price Forecast” is now included on pages 18-19
- Removal of sub-section “gasoline price review” on page 21
- Several wording changes under sub-section “the need for flexibility” on pages 23-25
- Wording in sub-section “Fuels: Supply and Demand” is now included on pages 32-34
- New sub-sections “Wind and Solar” and “Waterpower” now included in “Maximizing existing assets” section on pages 35-36. *Important to note: IESO has not been identified as the source for information/background.*
- New text box on Ontario’s Labour Unions – page 42.
- Wording in sub-section “Modernizing the System” has now been added, such as energy management systems and DERs, on page 46

Because we have not been given a formal opportunity for review, I ask that you review the attached changes and only flag major concerns or issues. If there are any, please let me know by EOD tomorrow, or early Monday at the latest.

Hi everyone,

Attached is the LTEP fact check sign-off log, and the latest version of the LTEP (same password as before). Ministry staff have identified facts and have noted who they think they belong to. IESO facts are highlighted in the LTEP in pink. They are also summarized in the log.

Next steps/process:

- Lead BUs have been identified for each of the facts – see attached log. *This is a first cut, so let me know if any changes are required.*
- Lead BUs are responsible for signing off on their facts – a director signature is required for each.
- In addition to a signature, source materials are also required for a ministry binder. Source materials can be snapshots of web materials (and associated URL), presentations, reports etc. Source materials are limited to one page per fact.
- When providing the source materials, please ensure they are clearly marked with the fact number and LTEP page.

Having gone through the IESO facts, I note that some of them are more editorial than factual. If you have any concerns with signing-off on the identified facts, please flag that for me in your response.

The Ministry is looking to sign-off on the LTEP on Tuesday. In order to have our consolidated log sent over to them in time, **please provide your sign-offs and supporting materials by Monday at 10 pm.**

On a related noted, I will be going through the LTEP document now and noting down changes from the previous iteration. I'll flag any issues/concerns with updated language.
