Bernard/George,

I am writing to provide an update on two developments today with respect to the GA financing initiative.

First, the Minister has sent Bernard the attached letter requesting OPG prepare a plan and recommendation on implementation of the GA financing. The letter is very helpful. We will prepare Bernard's response and seek approval to apply his signature on Tuesday.

Second, OPG was requested to sent the Ministry the form of shareholder resolution that would be needed to amend OPG's Articles of Amalgamation to permit us to access capital markets. We have provided the form of that resolution in the email below. Some aspects of this file are moving fairly quickly, and it is possible that the Minister may sign and issue this resolution before OPG has submitted its plan. While a bit out of sequence before we submit our plan to the Board and the Shareholder, if this occurs it will be very helpful to OPG (we have been trying to affect this change for 10 years!) and wanted to let you know. We will provide update at the Special Cttee meeting on Wed. April 19th.
