Please find enclosed Osler's comments on the draft legislation, also blacklined to v. 3. This remains subject to further review and comment by the Dealers.

We have done a preliminary review of the mark-ups from Torys/OPG and Stikeman/IESO, and are largely in agreement with their comments. However, we would note the following in respect of the Torys mark-up (which we have not yet had an opportunity to discuss with Torys):

- (1) Torys proposed revision to add a new section (1.4) to new section 53.1 of the Electricity Act is problematic as drafted. If it is necessary to be included, we would like to see it limited to recording the assets and liabilities for accounting purposes and requiring a note on the balance sheet indicating that the assets are held in trust and not available to OPG's creditors; and
- (2) we are concerned that the deemed trust language they added in 11xx(4) and 12xx(4) would not be enforceable on insolvency and that we would strongly prefer that true trusts be established.

All - Please find attached the draft "Intergenerational Fairness in Hydro Rates Act, 2017". A tremendous amount of work has gone into getting to this draft and much more work is required to get this ready for the House. The goal of sharing this document now is to further the process we have engaged in over the last weeks. In the attached, we have included notes to try to address where the drafting is not yet consistent with our thinking. These notes are neither comprehensive nor complete. They are intended only as flags and as colour to the draft. We have not forgotten the comments that you have already provided and we are continuing to working through the translation of the commercial terms we have been discussing into legislative language.

For ease of reference, included with the draft bill are the partially updated Blakes' summary, a chart that attempts links the articles in that document to the sections of the bill (which is imperfectly numbered at best) and excerpts from the Electricity Act and the Ontario Energy Board Act, related to the consequential amendments.

In your review, please focus on the broad stroke concepts, rather than the minutia, and keep in mind the cascade of instruments that will be required – legislation first, then regulations and finally commercial agreements. We look forward to discussing the broader concepts on Monday
