Ontario's Fair Hydro Plan

On March 2, 2017, the Province announced Ontario's Fair Hydro Plan (the Plan) aimed at reducing electricity bills by 25 percent on average for all residential consumers in the province. As part of the Plan, the Province has proposed refinancing a portion of the Global Adjustment costs over a longer time period for Regulated Price Plan eligible customers (e.g., residential, farm, small businesses). On May 11, 2017, the Province introduced legislation that, if passed, will enable the IESO and OPG to work together to undertake this financing as requested by the Province. ~~OPG was involved in the drafting process for the legislation to ensure that the financing aspects of the Plan can be operationalized with commercial value to OPG.~~ Any final agreement to implement OPG's involvement with the Plan is subject to approval by OPG's Board of Directors, which has established a Special Committee to provide oversight on behalf of timely strategic and other guidance to OPG management in connection with the implementation of the Plan and to make a recommendation to the Board of Directors.
