To FHT Management Oversight Committee Members:

We are pleased inform you that the Fair Hydro Trust's first purchase of the IESO's regulatory asset was successfully executed this morning after DBRS provided the short-term debt rating yesterday of R1-High (highest rating category for short-term debt) which enabled the banks to provide their share of funding to the Trust. A total of \$1.18 billion was funded by the following:

- * 51% or \$601M from short-term warehouse facility with a bank syndicate comprised of CIBC, RBC, and Goldman Sachs
- * 44% or \$519M from the Province's equity injection in exchange for 12.2 million Class A shares
- * 5% or \$59M from OPG
