John,

I've discussed this with Sheen, and we require clarification of a couple of things:

1. Are you looking for a comparison of FHP actual costs versus FAO or AG? Sheen sent you comparison against AG cost estimates on Wednesday, and actual interest costs are expected to be \$3 B lower than AG estimates (\$19 B vs \$22 B). The FAO report from Spring 2017 states FHP is saving rate payers \$24 B over 29 years. Are you looking for us to update the savings based on our most up date interest rates/debt profile? This would be difficult because Sheen doesn't have the data underlying the FAO numbers.
2. With respect to the relative cost of the program versus the electricity sector, we can provide the current cost of the program and highlight what the cost would be based on the average spread for the electricity sector. (i.e. The estimated financing cost is \$19 B based on an interest rate of x%. If the rate was x%, the cost of the program would be an additional \$x B.
