Business of the Issuer: Fair Hydro Trust (the "Issuer"), a special purpose trust established under the laws of the Province of Ontario, and caused to be established by Ontario Power Generation Inc. ("OPG"), as Financial Services Manager, has created a program providing for the offering and issuance of senior notes. The Issuer was established in connection with the *Ontario Fair Hydro Plan Act, 2017*; the Province of Ontario announced its Fair Hydro Plan on March 2, 2017, which proposed to lower the average electricity bill for eligible customers by 25%.
