

Definitions

"Affiliate" means, with respect to a person or entity, any individual, corporation, partnership, firm, joint venture, association, joint-stock company, trust or unincorporated organization, directly or indirectly controlling, controlled by, or under common control with, such person or entity.

"Control" means the possession, directly or indirectly, of the power to direct the management or policies of a person or an entity. A voting interest

"Publicly Traded" means any company that issues securities.

"Securities" include stocks, stock options, bonds, and any other instruments of debt or equity.

"Ultimate Parent" is the topmost responsible entity within the corporate hierarchy.

"Intermediate Parent" is any entity in the corporate hierarchy in between the ultimate parent company and the Applicant/Customer.

Instructions

- 1) Verify Applicant/Customer information, *i.e.* legal name; whether the Applicant/Customer is publicly traded, and trading symbol (if applicable).
- 2) List all Affiliates of Applicant/Customer.
- 3) Indicate whether each Affiliate is publicly traded, its trading symbol (if applicable), and relationship to the Applicant/Customer. Also indicate
- 4) List the corporate revenue for each publicly traded entity. Please use the most recent annual revenue reported by the company.
